Introduction:

Bandung, City of Flowers, is the provincial capital of West Java and Indonesia's third largest city. Known in colonial times as the Paris of Java because of its European ambiance and sophistication, Bandung shares with Miami a fine legacy of Tropical Deco architecture dating from the 1920's.

Situated on a plateau in the beautiful Parahyangan mountains, Bandung's pleasant climate and lush surroundings have offered an escape from the heat of the lowlands since the mid 19th century when it was the heart of the region's most prosperous plantation area. Host to the historic Asia Africa conference in 1955, Bandung is now a centre of higher education, commerce and aircraft industry which despite its modern amenities still retains much of its colonial era charm.

Bandung is also renowned for its shopping, particularly for shoes, textiles, clothing and denims which are found in the colourful Jeans street. Easily reached from Jakarta by train, road or air, Bandung, with its cool mountain air is a popular second stop for those visiting the national capital Jakarta and an essential stay-over for travellers en-route through Java.

Objective:

The Indonesian Business Centre and the Indonesian Investment Promotion Board will co-organise a Singapore Indonesia Business Meet, in Bandung, West Java – Indonesia on 19th - 23rd July 2010. The business meet will be specially tailored for producers, buyers, distributors and retailers of agro products, garments, textiles, bags and shoes respectively. Nevertheless, the meeting will be of interests to those investors in infra-structure development, real-estate or the building industries, as the Indonesian Investment Board (BKPM) will brief participants on potential infra structural projects on various provinces in Indonesia.
